

**Protection and hygiene concept
for the sports event
23rd Lippeweidpokal 2021 of the Flugsportgruppe Lünen Dept. of Model Flying**

General

In order to protect the participants of the sporting event of the Flugsportgruppe Lünen Abt. Modellflug from a further spread of the Covid-19 virus, we undertake to comply with the following infection protection principles and hygiene rules:

The competition will be held exclusively outdoors on the gliding field.
Proof of vaccinated, recovered, tested status of all persons participating in the competition will be checked.
We will ensure the minimum distance of 1.5 meters as comprehensively as possible in all areas.
Persons with respiratory symptoms (unless cleared by a doctor e.g. cold)
we keep them away from the event area, etc.
In the case of suspected cases, we apply a defined procedure for clarification (e.g. in the case of fever)

Measures to ensure the minimum distance of 1.5 m

The general rules of conduct on distance, hygiene and masks are to be observed as comprehensively as possible in all areas.
Everyone is urged to maintain a minimum distance of 1.5 m from other persons wherever possible and to ensure adequate hand hygiene.

Wearing mouth-to-nose coverings:

Must be brought by all participants (6 years and older) and worn whenever the required minimum distance of 1.5 m cannot be maintained. (queuing areas, waiting lines).
Wearing a mask during the competition is waived, as only immunized participants/pilots (vaccinated, recovered and tested) will meet in the open.
Active pilots are exempt from the mask obligation during a flight.

Instructions for action in suspected cases

The organizer must be informed immediately about the risk of infection and possible symptoms. informed immediately.

All participants with symptoms of illness are to be excluded from the event. excluded from the event.

Any infections that occur are to be reported to the responsible public health department immediately reported to the responsible health office and contact tracing is supported.

In suspected cases, a defined procedure for clarification and contact tracing is applied.

Other measures:

Hand hygiene:

Washing facilities, liquid soap, hand sanitizer and disposable towels are provided.

Postings are used to remind people to practice regular hand hygiene through hand washing and hand sanitizing.

Sneeze and Cough Etiquette:

Care is taken to ensure that the general basic rules of sneezing and coughing etiquette are observed:

When coughing and sneezing, maintain the greatest possible distance, turn away if possible cough and sneeze into the crook of your arm or into a paper handkerchief, which is then disposed of.

is disposed of afterwards.

Wash hands thoroughly after blowing nose/sneezing/coughing.

Control and regimentation of participants*:

To ensure traceability, the competition will be entered in the "LUCA" and "Corona Warn" app.

The participant lists with names, phone and email addresses of the pilots are reported.

There will be a neutral observer on site who will take care of the implementation of the Hygiene concept and gives hints if necessary.

Handling of objects:

All objects (e.g. writing utensils, signaling devices, etc.) are to be used on a person-specific and must be brought by the participants themselves.

If this is not possible, thorough cleaning/disinfection is to be done after each use.

Food and drink:

There will be no catering facilities with fixed seating or standing areas.

Drinks and currywurst will be offered as a ToGo option.

At least one medical mask (so-called surgical mask) must be worn in the queuing areas as well as directly adjacent to the sales booth, cashier area. Here the distance of 1.5 m is to be kept. This is guaranteed by floor markings. This will be pointed out by signs.

The sales booth and the cash desk area will be provided with a protection made of Plexiglas and/or transparent foil.

Proof of vaccinated, recovered, tested status:

Submission of a written or electronic negative test result of.

(a) a PCR test performed 48 hours or less ago,

(b) a POC antigen test performed 48 hours or less ago.

Submission of the vaccination certificate or electronic vaccination status.

Presentation of the proof of the recovered status according to the Corona Protection Regulation.

Upon arrival or before the start of the competition, the respective proof of immunization or test will be checked with an official identification document, documented and marked by means of an entry band.

Persons who cannot show proof of the respective immunization or test certificate will be excluded from the competition.

Sanitary areas, canteens and break rooms:

Signs will be posted at central points and at sanitary facilities regarding the hygiene standards will be posted.

The hygiene concept will be made known to the participants prior to their arrival and will also be displayed at the airfield

Instruction of the participants:

The acceptance of the hygiene concept is a prerequisite for participation.

All participants of the event confirm the compliance with the rules with the written registration.

The participants will be informed in the announcement, in an additional letter by mail and on site. and on site in the briefing at the beginning of the event.

Other protective and hygienic measures:

This hygiene concept will be presented to the responsible authorities upon request. All current regulations of the state of North Rhine-Westphalia will be adhered to and this hygiene concept will be continuously adapted to these.

The attendance of all participants will be recorded and the necessary data for possible contact tracing.

At central points and at the sanitary facilities signs are attached to the hygiene standards will be posted at central points and sanitary facilities.

The hygiene concept will be made known to the participants prior to their arrival and will also be displayed at the airfield. Acceptance of the hygiene concept is a prerequisite for participation.

The maximum number of participants will be limited to 100 (one hundred).

There will be a neutral observer on site, who will take care of the implementation of the hygiene concept and gives advice if necessary.
